Implementing the ***Outline Program for the Building of a Social Credit System (2014-2020)*** and the ***Guiding Opinions of the State Council on Establishing a Sound Joint System for Encouraging Credibility and Punishing Dishonesty to Accelerate the Building of a Social Credit System,***

Facilitating credit culture building of the civil aviation industry, safeguarding orderly civil aviation activities, and promoting healthy civil aviation development

## Administration Measures

---

- ❑ One record
- ❑ One Credit record for the concerned person and entities
- ❑ The record will be regularly published through the CAAC's official website



## Administration Measures

---

### □ Two lists

- The Grey list and the Blacklist.
- Grey list will be activated from January 1, 2020. It will automatically record information about illegal activities or anyone who receive the Rectification notice issued by CAAC.



## Administration Measures

---

- ❑ Black list has been implemented from January 1, 2018. It is clarified by Art.8 of the document, which includes 15 serious dishonest behaviors, such as transporting dangerous goods illegally, resulting in transportation incidents, and so on.



## Administration Measures

---

- ❑ Three withdrawal modes
  - ❑ Automatic withdrawal
  - ❑ Application for withdrawal
  - ❑ Withdrawal in advance by recovering the credit willingly





## Administration Measures

---

### Four remedies

- Be informed , petition before recorded
- Dissent ,after recorded
- Apply for administrative reconsideration
- Bring an administrative suit before court



## Administration Measures

---

- ❑ Five punishment measures
- ❑ Multiple punitive measures undertaken by CAAC
- ❑ United punishment system
- ❑ Association sanctions
- ❑ Market restrictions
- ❑ Social supervision



## Advice

---

- ❑ Travellers who conduct special behaviors in airports or aircrafts shall be meted out administrative punishments and criminal liability by public security bureau.
- ❑ Become effective since May 1, 2018.



## Advice

---

- ❑ Fabricate and propagate spurious information intentionally, which relates to the security of civil aviation;
- ❑ Use counterfeit, altered, other people's ID card or boarding certificate;
- ❑ Block, forcibly occupy, and strike check-in counters, security checkpoints and boarding gates (counters);



## Advice

---

- ❑ Carry or consign perilous, prohibited, controlled goods prescribed by national law and regulation; Hide intentionally prohibited and constricted goods prescribed by civil aviation regulation;
- ❑ Forcibly intercept aircraft, break in aircraft cockpit, runway and airfield;
- ❑ Hamper or instigate others to hamper aircrew, security and check-in staff, execute personal attack or behave in a threatening manner;



## Advice

---

- ❑ Forcibly occupy seats, baggage racks, fight and provoke troubles, deliberately damage, steal, open the aircraft and its equipment;
- ❑ Use naked light, smoke, use electronic devices without listening to dissuasion;
- ❑ Steal others' property in the aircraft.
